



WWC Texas RHC and WWC License are wholly-owned (100%) subsidiaries of WWC License Holding L.L.C. ("WWC LH"), which is a wholly-owned (100%) subsidiary of Western Wireless Corporation ("Western"). WWC HC is also a wholly-owned (100%) subsidiary of Western. WWC Texas is a Delaware limited partnership; WWC License and WWC LH are Delaware limited liability companies; WWC Texas RHC and WWC HC are Delaware corporations; and Western is a Washington corporation, all with principal business offices at 3650 13 1st Avenue, S.E., Suite 400, Bellevue, Washington 98006.
