

Credit Suisse First Boston Equity Partners, L.P. (CSFB) may be considered a **beneficial owner of Winstar Communications, Inc. (debtor-in-possession)**. As of March 31, 2001, CSFB owns approximately 400,000 shares of the Series G preferred stock of **Winstar** Communications, Inc. and approximately 120,000 shares of the Series H preferred stock of **Winstar** Communications, Inc. Taken together, the stock ownership of CSFB roughly equates to 10.5% of the voting stock of the **Winstar** Communications, Inc. The assets of **Winstar** Communications, Inc. have since been assigned to **Winstar** Communications, Inc. (debtor-in-possession).
