

**OWNERSHIP DISCLOSURE STATEMENT FOR
VOICESTREAM WIRELESS HOLDING CORPORATION**

Applicant, **VoiceStream** Wireless Holding Corporation (“**VoiceStream** Holding”), a Delaware corporation, submits this updated FCC Form 602 to incorporate the proposed new ownership and licenses resulting from an impending reorganization (“Aerial reorganization”) with Aerial Communications, Inc. (“Aerial”). On July 15, 1999, Voice&ream Holding filed an updated Form 602 to reflect a reorganization involving **VoiceStream** Wireless Corporation (“**VoiceStream**”) and Omnipoint Corporation (“Omnipoint”), which is still pending Commission approval (“Omnipoint reorganization”).^{1/} As explained in certain of the Omnipoint reorganization applications which specifically pertain to the transfer of control of **VoiceStream**,^{2/} the combination of certain prior non-substantial ownership changes in **VoiceStream** coupled with the change in stock ownership caused by the Omnipoint reorganization required that **VoiceStream** obtain long form approval to transfer control of its subsidiaries’ licenses. The ownership changes in **VoiceStream** caused by the Aerial reorganization in relation to those already proposed in the Omnipoint reorganization applications are minor in nature ^{3/} because they would change **VoiceStream**’s ultimate stock ownership and voting power only by approximately 25% and add only one new member, an appointee by TDS, to **VoiceStream** Holding’s Board (enlarging the combined company’s Board from sixteen to seventeen members). If, however, the Aerial transaction closes first, the new Aerial stockholders would compose approximately 35% of **VoiceStream**’s ultimate ownership and voting power; the cumulative effect of this change coupled with prior non-substantial changes in ownership in **VoiceStream** would require long form approval.^{4/} This updated Form 602 reflects the ownership information which would be applicable depending upon the sequence of the closing of the two reorganizations.

Upon consummation of either or both of the pending reorganizations, **VoiceStream** Holding will be a leading provider of telecommunications service primarily engaged in acquiring,

constructing, and operating personal communications service (“PCS”) systems and related telecommunications systems throughout the United States. **VoiceStream** Holding will hold its telecommunications assets, as is pertinent, through its direct wholly-owned subsidiaries: **VoiceStream**; Omnipoint; and Aerial.

OWNERSHIP AND CONTROL OF VOICESTREAM HOLDING

A. If the Omnipoint reorganization closes before the Aerial reorganization, the following entities or persons will hold a ten percent or more ownership or voting interest, or other positional interest potentially subject to reporting, in VoiceStream Holding:

I. HUTCHISON TELECOMMUNICATIONS PCS (USA) LIMITED

Hutchison Telecommunications PCS (USA) Limited ("Hutchison USA"), a British Virgin Islands corporation, post-reorganization will hold 55.9 million shares (29.35%) of VoiceStream Holding's stock. Of this amount, approximately 34.7 million shares will be common stock (voting) and the balance will be preferred stock (non-voting). Hutchison USA's primary business is to hold stock in VoiceStream Holding.^{2/} Following the closing of both reorganizations, Hutchison USA's interest will decline to 23.08%.

Hutchison USA is a wholly-owned subsidiary of Hutchison Whampoa Limited ("Hutchison Whampoa"), a Hong Kong limited liability holding company. Hutchison USA, HTHL and

Hutchison Whampoa are located at Hutchison House, 10 Harcourt Road, Hong Kong.^{6/} Hutchison Whampoa is principally engaged in six core businesses: telecommunications, real estate, shipping, retail, manufacturing, and energy. Hutchison Whampoa holds telecommunications interests in Hong Kong, Great Britain, and southeast Asia; aside from its interest in **VoiceStream** Holding, however, it holds no other interests in Commission-regulated businesses.

II. **OTHER INTERESTS**

Based on the criteria set forth in Section 1.2 112(a) of the Commission's Rules, and the Wireless Telecommunication Bureau's May 25, 1999, Public Notice clarifying information to be disclosed on FCC Form 602,^{7/} there are no officers or directors of **VoiceStream** Holding who have disclosable interests in **VoiceStream** Holding. Out of an abundance of caution, however, **VoiceStream** Holding provides additional information regarding the officers and directors listed below, either because they represent (but do not control) shareholder interests of 10% or greater on **VoiceStream** Holding's Board of Directors or because they are key management personnel within **VoiceStream** Holding.

i. **Canning Fok and Hans R. Snook**-- Mr. Fok is Hutchison Whampoa's Group Managing Director. Mr. Snook is the Managing Director of Orange plc, an affiliate of Hutchison Whampoa, and a director of another Hutchison Whampoa affiliate. Messrs. Fok and Snook are citizens of the United Kingdom; the principal business office of each is located at Hutchison House, 10 Harcourt Road, Hong Kong. As officers of Hutchison Whampoa and affiliates thereto, each represents **VoiceStream** Holding common stock held by Hutchison USA and HTHL and, indirectly, by Hutchison Whampoa. Messrs. Fok and Snook are members of **VoiceStream** Holding's Board of Directors.

ii. **John W. Stanton**-- Mr. Stanton is Chairman of **VoiceStream** Holding's Board of Directors and its Chief Executive Officer. He is a United States citizen with principal business offices at 3650 131st Avenue, S.E., Suite 400, Bellevue, Washington 98006.

iii. **Robert R. Stanleton**-- Mr. Stanleton is **VoiceStream** Holding's President and a member of its Board of Directors. He is a United States citizen with principal business offices at 3650 131st Avenue, S.E., Suite 400, Bellevue, Washington 98006.

B. If the Aerial Reorganization Closes Before the Omnipoint Reorganization the following entities will hold a ten percent or more ownership or voting interest, or other positional interest potentially subject to reporting, in **VoiceStream** Holding:

I. HUTCHISON USA

Hutchison USA will hold 22.9 million shares (15.52%) of **VoiceStream** Holding's stock.^{8/}

Hutchison USA is a wholly-owned subsidiary of Hutchison Whampoa, a Hong Kong limited liability holding company.

II. TELEPHONE AND DATA SYSTEMS, INC. ("TDS")^{9/}

After the Aerial reorganization, TDS will hold approximately 35.6 million shares of **VoiceStream** Holding's common stock, or approximately 24.10%. Following the closing of both reorganizations, TDS' interest will decline to approximately 16.18%.

Through its various subsidiaries, TDS operates primarily in the cellular; local telephone and personal communications services. For TDS' interests in other telecommunications companies, please see its FCC Form 602 filed on September 28, 1999, FCC File No. PC-NS-275-200.

III OTHER INTERESTS

Upon closing of the Aerial reorganization, TDS will have the right to designate one director of **VoiceStream** Holding. TDS has not at this time determined who it will propose to designate.

FOREIGN OWNERSHIP

The level of foreign ownership in **VoiceStream** Holding following the Aerial reorganization will depend upon the closing sequence of the Aerial and Omnipoint reorganizations.

A. If the Omnipoint Reorganization Closes Before the Aerial Reorganization

In connection with the Aerial reorganization, **Sonera** Corporation, formerly known as **Sonera** Ltd. and Telecom Finland, Ltd. ("Sonera"), a Finnish company engaged in providing advanced data and media communications solutions and services to a range of international corporate investors, invested \$75 million in Aerial and \$155 million in Aerial Operating Company, Inc. (a subsidiary of Aerial) ("**AOC**")¹ at an equivalent price of \$22.00 per share of Aerial common stock. **Sonera** previously invested approximately \$200 million in AOC. Immediately prior to the Aerial reorganization, all of **Sonera's** shares in AOC will be exchanged into shares of Aerial common stock. **Sonera** will exchange all of its shares in Aerial for stock in **VoiceStream** Holding upon the closing

of the Aerial reorganization. Additionally, at the closing of the Omnipoint reorganization, **Sonera** will invest an additional \$500 million directly in **VoiceStream** Holding. Both investments will give **Sonera** an aggregate ownership interest of approximately 8.63% in **VoiceStream** Holding. The largest foreign investor in **VoiceStream** Holding is Hutchison USA, which is wholly owned and controlled by Hutchison Whampoa, a Hong Kong company. Hutchison Whampoa is engaged in six core businesses including telecommunications. Hutchison Whampoa's telecommunications holdings include fixed line, cellular phone and paging services. Hutchison USA's present aggregate ownership and voting interest in **VoiceStream** is approximately 24%. At the closing of the Omnipoint reorganization, Hutchison USA will acquire additional stock (namely, a combination of common and preferred) in **VoiceStream** Holding, resulting in an ownership and voting interest of approximately 29.35%.^{10/} **VoiceStream** Holding's total foreign ownership will consist of the following components after closing on both reorganizations:

- Hutchison USA- approximately 23.08%;
- 2. TDS- approximately 2.27%; and
- 3. **Sonera**- approximately 8.63%.

The aggregate indirect foreign ownership following both reorganizations will be approximately 33.27% (non-voting), and the voting interest approximately 33.20%.

B. If the Aerial Reorganization Closes Before the Omnipoint Reorganization

If the Aerial reorganization closes before the Omnipoint reorganization, **Sonera's** investment in **VoiceStream** Holding will be limited to the shares of Aerial and the shares of AOC that **Sonera** acquired in exchange for its \$230 million investment in Aerial, and the shares that **Sonera** owned prior to entering into the arrangements contemplated by the Aerial Reorganization Agreement. In this event, **Sonera's** ownership interest in **VoiceStream** Holding will be approximately 6.92%. Hutchison USA's ownership interest in **VoiceStream** Holding will only be 15.52% because, among other factors, it will not yet have made its additional \$807 million investment which is conditional on the Omnipoint transaction closing. **VoiceStream** Holding's total foreign ownership will consist of the following components after the Aerial reorganization closes:

- Hutchison- approximately 15.52%;
- 2. TDS- approximately 3.37%; and

3. **Sonera**- approximately 6.92%.

The aggregate indirect foreign ownership following the Aerial reorganization will be approximately 24.95% (non-voting), and the voting interest approximately 24.87%.

C. Prior Commission Rulings Regarding Alien Ownership in VoiceStream and Aerial:

By Order released December 29, 1997, the Commission granted a petition for declaratory ruling under Section 310(b)(4) of the Communications Act filed by **VoiceStream** (then named Western PCS Corporation) and **VoiceStream's** then 100% corporate parent, Western Wireless Corporation, to permit indirect foreign ownership exceeding the 25% statutory benchmark.^{11/} Therein the Commission permitted an aggregate level of alien ownership in **VoiceStream's** subsidiary licensees of up to and including 39.9%. This petition described the public interest benefits that would result from a substantial investment in **VoiceStream** by Hutchison Whampoa.

Subsequently, by public notice released June 4, 1999, Report No. TEL-00095, DA No. 99-1059, the Commission granted a second Petition for Declaratory Ruling filed by **VoiceStream**, pursuant to Section 310(b)(4) of the Communications Act to increase the level of indirect foreign ownership in its subsidiary licensees to 49.9%. See FCC File No. ISP-PDR-19990416-00004. In this petition, **VoiceStream** explained that the filing was made out of an abundance of caution because Northern Telecommunications Inc.'s ("**Nortel**")^{12/} purchase of **VoiceStream** preferred non-voting stock was more akin to debt than equity. The nature of the preferred stock (widely known as "payment in kind" or "**PIK** preferred") that Nortel was purchasing is such that it would have been treated as a surrogate for debt in the capital markets. The Commission granted **VoiceStream's** petition.^{13/}

Regardless of whether the Aerial reorganization closes before or **after** the Omnipoint reorganization, the proposed level of indirect foreign ownership in the licensees controlled by **VoiceStream** Holding will be below the 49.9% threshold the Commission previously approved for **VoiceStream**. Moreover, the ownership and voting interests of the combined company's largest foreign investor, Hutchison Whampoa, will be any of 15.52% (Aerial first), 29.35% (Omnipoint first) or 23.08% (combined), whereas Hutchison Whampoa presently holds approximately 24% of **VoiceStream**.

The level of foreign ownership for which **VoiceStream** Holding seeks consent is also consistent with prior Commission actions regarding Aerial. In Telecom Finland, Ltd., the

Commission found that it was in the public interest to permit U.S. subsidiaries of Telecom Finland, Ltd. ("TFL"), a wholly owned subsidiary of the PT Finland, Limited (which is a private holding company of the Government of Finland), to participate in the (then upcoming) auctions for and to hold PCS and LMDS licenses.^{14/} The Commission stated that TFL's additional investments have significant public interest benefits, namely "foreign investment provides capital that can fuel investment in state-of-the-art infrastructure that leads to economic job growth and job formation in the U.S. economy and facilitates competition among U.S. carriers both at home and abroad."^{15/} In addition, on July 10, 1998, the Commission found it within the public interest to allow TFL (which has since changed its name to Sonera) to own up to 49.9% of Aerial.^{16/} As previously noted, the level of foreign ownership in VoiceStream Holding after both reorganizations will be below 49.9%. None of the foreign investors will control VoiceStream Holding or its Board of Directors.

By granting the instant request, the Commission will permit approximately \$1.7 billion dollars in new foreign investment into the combined company and thereby facilitate creation of a fifth national competitor in the wireless market - a competitor utilizing a different technology and one capable of providing worldwide GSM service. Grant of the requested relief is demonstrably in the public interest.
