

Description of Liberty Media Group's Ownership of its Interests in Teligent, Inc.

Microwave Services, Inc. ("MSI") is the registered holder of 21,436,689 shares of Class A Common Stock of Teligent, Inc. ("Teligent"). MSI's ownership represents approximately 39.11% of the Common Stock of Teligent. MSI is an indirect wholly owned subsidiary of AGI LLC through Microwave Holdings, L.L.C. AGI LLC's sole member is AT&T Corp. ("AT&T"). AGI LLC's sole manager is Liberty AGI, Inc. ("Liberty AGI"). Attached hereto is a diagram entitled "Post Merger - Liberty Media Group's Ownership of its Interest in Teligent, Inc. - Step 1" depicting the current ownership structure of MSI. Under AGI LLC's governing documents, Liberty AGI, as manager, is solely vested with the authority to direct the management of AGI LLC, including, but not limited to, making determinations regarding the disposition and voting of the stock of Teligent, Inc.

Liberty AGI is a member of the Liberty Media Group, which was created in March 1999 in connection with AT&T's acquisition of Tele-Communications, Inc. ("TCI"). Although AT&T and its subsidiaries own 100 percent of the stock of each member of the Liberty Media Group, AT&T's ownership of the Liberty Media Group has been structured to distinguish the economic interests of the holders of AT&T common stock and the holders of the Liberty Media Group tracking stock. More importantly, AT&T's ownership of Liberty AGI, and the other member companies of the Liberty Media Group, has been structured in such a way as to provide the Liberty AGI with operational independence from AT&T.

The members of the Liberty Media Group are managed independently from AT&T. A majority of the individuals serving on the boards of directors of each of Liberty and Liberty AGI are persons who were designated by TCI prior to the AT&T/TCI Merger and are not otherwise employees of AT&T or its affiliates.¹ These directors are responsible for appointing the executive officers of Liberty and Liberty AGI. Substantially all of the currently serving executive officers of Liberty and Liberty AGI held equivalent positions with Liberty prior to the AT&T/TCI Merger and are not otherwise employees of AT&T or its affiliates. The governing documents for both Liberty and Liberty AGI provide that persons designated by TCI prior to the AT&T/TCI Merger will continue to constitute a majority of those directors until 2006 and that such directors are not removable by AT&T prior to such time, except for cause.²

Pursuant to the terms of the merger, which closed on January 14, 2000, within six months of the closing AT&T will transfer all of the equity in AGI LLC to Liberty AGI in exchange for common stock of Liberty AGI representing the value of the equity interest in AGI LLC (the "Share Exchange"). The common stock of Liberty AGI held by AT&T following the Share

² AT&T and the Liberty Media Group have instituted various additional measures to establish the operational independence of the Liberty Media Group companies, including, (1) the board of directors of each Liberty Media Group company are solely responsible for managing each company's respective businesses and (2) pursuant to contract the Liberty Media Group may compete with AT&T's cable television, telephone, and internet businesses and has no obligation to share its financial resources or corporate opportunities with such businesses.


