**Nature of Transfer of Control**

George M. Batsche, deceased, was the sole stockholder of Texas Electronic Transport Co. (“TETC”). TETC is an FCC regulated microwave common carrier providing service to CATV systems in southern Texas. Upon Mr. Batsche’s death, the FCC approved the transfer of control of TETC to George M. Batsche, Jr., Executor of the estate of George M. Batsche (FCC file no. 94-1 3 125).

Following probate, Probate Court Number, One, Travis County, Texas, has ordered, inter **alia**, distribution of the stock of TETC, (see Court Order attached), to the heirs of George M. Batsche. The proposed transferees are George M. Batsche, Jr., Winifred S Batsche, and James E. Fortune. See FCC form 602 attached.

PETITION FOR DISCHARGE  
(Full Waiver)

Petitioner, as Ancillary Personal Representative of the Florida estate, alleges:

1. The decedent, GEORGE M. BATSCHE a/k/a GEORGE MILTON BATSCHE, a resident of Austin, Travis County, Texas, died on January 1, 1994, and Letters of Administration were issued to Petitioner on June 23, 1994.

2. Petitioner has fully administered this estate by making **payment**, settlement, or other disposition of all claims and debts that were presented, and by paying or making provision for the payment of all taxes and expenses of administration.

3. 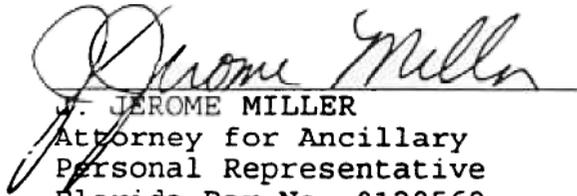

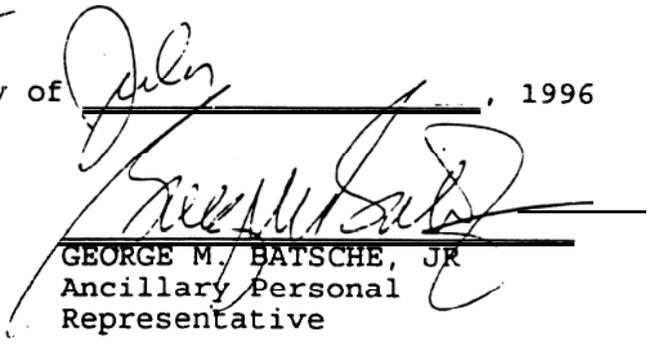
