





SBC Communications Inc. ("**SBC**"), through various wholly owned subsidiaries, indirectly holds approximately 60 percent of Cingular Wireless LLC ("**Cingular**"). **BellSouth** Corporation ("**BellSouth**"), through various wholly owned subsidiaries, indirectly holds approximately 40 percent of Cingular. Cingular Wireless Corporation, which is owned and controlled equally by SBC and **BellSouth**, directly holds less than one percent of **Cingular**.

SBC holds its indirect interests in Cingular and Cingular Wireless Corporation through SBC Alloy Holdings, Inc. SBC Alloy Holdings, Inc. is jointly owned by nine wholly owned subsidiaries of SBC: Southern New England Telecommunications Corporation ("**SNET**"); The **Woodbury** Telephone Company ("**Woodbury**"); Pacific Telesis Group ("**PTG**"); New Southwestern Bell Mobile Systems, Inc. ("**New SBMS**"); New SBC Wireless, Inc. ("**New SBCW**"); AWACS, Inc.; Associated Communications Corporation ("**Associated**"); Radiofone Holdings, Inc. ("**Radiofone**"); and Ameritech Corporation ("**Ameritech**"). SBC directly owns SNET, PTG, New SBCW, and Ameritech. SNET directly owns Woodbury. New SBCW owns 80% and PTG owns 20% of New SBMS. New SBCW also owns Associated and Radiofone in addition to Delaware Valley Cellular Corporation, which directly owns AWACS, Inc.

BellSouth holds its indirect interests in Cingular through five (5) wholly owned subsidiaries: **BellSouth** Cellular Corp.; **BellSouth** Mobile Data, Inc.; RAM Broadcasting Corporation; **AB** Cellular Holding, LLC; and Wireless Telecommunications Investment Company LLC. **BellSouth** directly owns RAM Broadcasting Corporation and **BellSouth** Enterprises, Inc. **BellSouth** Enterprises, Inc. directly owns **BellSouth** Mobile Data, Inc. and **BellSouth** Mobile Systems, Inc. **BellSouth** Mobile Systems, Inc. directly owns **BellSouth** Cellular Corp. **BellSouth** Cellular Corp. directly owns BSCC of Houston, LLC and **BellSouth** Mobile Data, Inc. SBC Alloy Holdings, Inc. and **BellSouth** equally own and control Cingular Wireless Corporation. Therefore, although the economic interests in Cingular Wireless LLC are divided approximately 60/40 between SBC subsidiaries and **BellSouth** subsidiaries, control is equally shared.
