

The disclosable interest holder is not controlled by Applicant, thus Applicant does not have knowledge of all interests held by this entity.			

SBC Wireless, LLC is wholly owned by Cingular Wireless LLC. Cingular Wireless LLC is approximately 60% owned by SBC Alloy Holdings, Inc. and approximately 40% owned by three wholly owned subsidiaries of **BellSouth Corporation** (“**BellSouth**”), **BellSouth Cellular Corp.**; **BellSouth Mobile Data, Inc.**; and **RAM Broadcasting Corporation**. In addition, a de minimis share of Cingular Wireless LLC is held by Cingular Wireless Management Corp.

SBC Alloy Holdings, Inc. is jointly owned by nine wholly owned subsidiaries of SBC Communications Inc. (“SBC”), Southern New England Telecommunications Corporation (“SNET”); The **Woodbury** Telephone Company (“Woodbury”); Pacific Telesis Group (“PTG”); New Southwestern Bell Mobile Systems, Inc. (“New SBMS”); New SBC Wireless, Inc. (“New SBCW”); AWACS, Inc.; Associated Communications Corporation (“Associated”); Radiofone Holdings, Inc. (“Radiofone”); and Ameritech Corporation (“Ameritech”). SBC directly owns SNET, PTG, New SBCW, and Ameritech. SNET directly owns Woodbury. New SBCW owns 80% and PTG owns 20% of New SBMS. New SBCW also owns Associated and Radiofone in addition to Delaware Valley Cellular Corporation, which directly owns AWACS, Inc.

BellSouth directly owns RAM Broadcasting Corporation and **BellSouth Enterprises, Inc.**, which directly owns (1) **BellSouth Mobile Systems, Inc.**, which directly owns **BellSouth Cellular Corp.**, and (2) **BellSouth Mobile Data, Inc.**

SBC Alloy Holdings, Inc. and **BellSouth** equally own and control Cingular Wireless Management Corp., which – in addition to the de minimis ownership interest in Cingular Wireless LLC described above – controls Alloy LLC. Therefore, although the economic interests in Cingular Wireless LLC are divided approximately 60/40 between SBC subsidiaries and **BellSouth** subsidiaries, control is equally shared.
