





As more fully illustrated by the organizational flow chart attached hereto, the following information describes the relationship between the entities holding attributable ownership interests in Southwest PCS Licenses, LLC:

Southwest PCS, LP is the sole member of, and holds 100 percent of the membership interests in, Southwest PCS Licenses, LLC.

SWGP, LLC is the general partner of, and holds a 1 percent equity interest in, Southwest PCS, LP.

SWLP, LLC is the limited partner of, and holds a 99 percent equity interest in, Southwest PCS, LP. [REDACTED]

Alamosa Holdings, LLC is the sole member of and holds 100 percent of the membership interests in, both SWLP, LLC and SWGP, LLC.

Alamosa (Delaware), Inc. is the sole member of, and holds 100 percent of the membership interests in, Alamosa Holdings, LLC.

Alamosa PCS Holdings, Inc. owns 100 percent of the common stock of Alamosa (Delaware), Inc.

Alamosa Holdings, Inc. owns 100 percent of the common stock of Alamosa PCS Holdings, Inc.
