





AGREEMENT FOR EQUITY BONUS

This Agreement for Equity Bonus is entered into this ____ day of May, 2000, between the Law Firm of Ryan, Phillips, Utrecht & MacKinnon ("RPUM"), located in the District of Columbia, and U.S. Interactive d/b/a AccelerNet ("AccelerNet"), a Delaware limited liability company.

WHEREAS, AccelerNet has retained RPUM to provide legal, legislative and lobbying services ("Services"), looking toward the passage of legislation which would authorize the provision of two-way wireless data services utilizing UHF television spectrum in accordance with AccelerNet's business plan ("Legislation").

WHEREAS, AccelerNet desires to **incent RPUM** in the performance of its Services through the provision of a bonus in the form of equity in AccelerNet.

Now the parties hereto intending to be legal bound, agree as follows:

Provision for Equity Bonus. Upon the passage of the Legislation and its enactment into law, AccelerNet will issue to **RPUM** (or to such partners or employees as RPUM, at its option, may designate) equity equal to **.80** percent of the issued and outstanding equity interest in AccelerNet, or any successor entity, on a fully diluted basis as of the time the Legislation becomes law.

2. **Proxy in favor of Dean Mosely.** RPUM shall execute a proxy ("Proxy") allowing Dean M. Mosely to vote its equity interest in AccelerNet. For as long as Mosely shall hold either of the offices of Chairman or CEO of AccelerNet, such Proxy shall be considered coupled with an interest and shall be irrevocable except upon the happening of any of the following:
 - A. Mosely sells a majority of his equity interest in AccelerNet.
 - B. AccelerNet issues voting equity securities in a public offering.
 - C. AccelerNet proposes to sell all or substantially all of its assets.
 - D. AccelerNet files a petition under the U.S. Bankruptcy code, or under an applicable state bankruptcy statute, or a receiver is appointed for AccelerNet under applicable state law.

In the event of the happening of any of the events described in A-D, above, the Proxy shall be automatically revoked.

3. **Equity Certificate to Bear Legend** Any equity certificate shall bear a legend stating that it is subject to the Proxy.

4. **Parties to Comply with Applicable Securities Laws.** The parties hereto will take all steps necessary to comply with all applicable laws regulating the issuance and holding of securities.

5. **Designation of Equity Holder.** If **RPUM** designates one or more individuals to hold all or part of the equity issued by **AccelerNet** pursuant to Section 1, issuance of any equity interest to such individual shall be subject to such individual executing the proxy described in Section 2, above.

AGREEMENT FOR EQUITY BONUS

This Agreement for Equity Bonus is entered into this day of May, 2000, between the Law Firm of Ryan, Phillips, Utrecht & MacKinnon (“**RPUM**”), located in the **District** of Columbia, and U.S. Interactive d/b/a AccelerNet (“AccelerNet”), a Delaware limited liability company.

WHEREAS, AccelerNet has retained RPUM to provide legal, legislative and lobbying services (“Services”), looking toward the passage of legislation which would authorize the provision of two-way wireless data services utilizing UHF television spectrum in accordance with **AccelerNet’s** business plan (“Legislation”).

1. **Provision for Equity Bonus.** Upon the passage of the Legislation and its enactment into law, AccelerNet will issue to RPUM (or to such partners or employees as RPUM, at its option, may designate) equity equal to **.80** percent of the issued and outstanding equity interest in AccelerNet, or any successor entity, on a fully diluted basis as of the time the Legislation becomes law.

2. **Proxy in favor of Dean Mosely.** RPUM shall execute a proxy (“Proxy”) allowing Dean M. Mosely to vote its equity interest in AccelerNet. For as long as Mosely shall hold either of the offices of Chairman or CEO of AccelerNet, such Proxy shall be considered coupled with an interest and shall be irrevocable except upon the happening of any of the following:
 - A. Mosely sells a majority of his equity interest in AccelerNet.
 - B. AccelerNet issues voting equity securities in a public offering.
 - C. AccelerNet proposes to sell all or substantially all of its assets.
 - D. AccelerNet files a petition under the U.S. Bankruptcy code, or under an applicable state bankruptcy statute, or a receiver is appointed for AccelerNet under applicable state law.

In the event of the happening of any of the events described in A-D, above, the Proxy shall be automatically revoked.

3. **Equity Certificate to Bear Legend.** Any equity certificate shall bear a legend stating that it is subject to the Proxy.

Parties to Comply with Applicable Securities Laws. The parties hereto will take all steps necessary to comply with all applicable laws regulating the issuance and holding of securities.

Designation of Equity Holder. If **RPUM** designates one or more individuals to hold all or part of the equity issued by **AccelerNet** pursuant to Section 1, issuance of any equity interest to such individual shall be subject to such individual executing the proxy described in Section 2, above.
