

Applicant is a wholly-owned subsidiary of **PrimeCo PCS, L.P.** ( [REDACTED] which holds 80% of this interest directly, and 20% of this interest through its wholly-owned subsidiary, **Houston HoldCo LLC** (TIN: N/A) **PrimeCo PCS, L.P. is owned 50% by PCSCO Partnership** [REDACTED] and 50% by **PCS Nucleus, L.P.** [REDACTED]. **PCSCO Partnership is a wholly-owned, indirect subsidiary of Bell Atlantic Corporation** ("Bell Atlantic") [REDACTED]; **PCS Nucleus, L.P. is a wholly-owned, indirect subsidiary of Vodafone AirTouch, Plc** ("Vodafone") [REDACTED]. Additional information regarding Applicant's ownership is set forth below.

### I. OWNERSHIP OF APPLICANT'

#### A. PCSCO PARTNERSHIP

Bell Atlantic owns 100% each of Bell Atlantic Investments, Inc. (TIN: [REDACTED]) and NYNEX Corporation ([REDACTED]). Bell Atlantic Investments, Inc. owns 100% of Bell Atlantic Global Wireless, Inc. [REDACTED] which in turn owns 100% of Bell Atlantic Cellular Holdings, L.P. [REDACTED] through the following intermediate holding companies: **Bell Atlantic Mobile Systems, Inc.** [REDACTED], **Bell Atlantic Mobile Systems of Northern New Jersey, Inc.** [REDACTED], and **Bell Atlantic Personal Communications, Inc.** [REDACTED]. NYNEX Corporation owns 100% of NYNEX Mobile Communications Company ([REDACTED]) which in turn owns 100% of NYNEX PCS Inc. [REDACTED]. **Bell Atlantic Cellular Holdings, L.P., Bell Atlantic Personal Communications, Inc., and NYNEX PCS Inc. own 49%, 1%, and 50%, respectively, of PCSCO Partnership.**

#### B. PCS NUCLEUS, L.P.

Vodafone owns 100% of Vodafone International Operations Limited, a U.K. corporation. Vodafone International Operations Limited owns 100% of Vodafone International Holdings Limited and Vodafone Worldwide Holdings Limited, both U.K. corporations. Vodafone International Holdings Limited and Vodafone Worldwide Holdings Limited own, respectively, 74% and 26% of **Taskonly Limited**, a U.K. corporation. **Taskonly Limited** owns 100% of **Vodaphone Limited** and **Vodata Limited**, both U.K. corporations. **Vodaphone Limited**

and Vodata Limited own, respectively, 10% and 90% of Vodafone Luxembourg S.a.r. 1 ("Lux 1"), a Luxembourg corporation. Lux 1 owns 100% of Vodafone Luxembourg 2 S.a.r. 1 ("Lux 2"), a Luxembourg corporation. Lux 2 owns 100% of Vodafone Luxembourg 3 S.a.r. 1. ("Lux 3"), a Luxembourg corporation. The three Luxembourg entities own Vodafone US Partners (TIN: [REDACTED]) a Delaware general partnership, as follows: Lux 1 (10%), Lux 2 (89.99%) and Lux 3 (0.0089%). Vodafone US Partners is the 100% direct owner of **AirTouch Communications, Inc.** ([REDACTED]), which in turn is the 100% owner of **AirTouch PCS Holding, Inc.** (TIN: [REDACTED]). **AirTouch Communications, Inc.** and Air-Touch PCS Holding, Inc. own 49% and 51%, respectively, of PCS Nucleus, L.P. [REDACTED]
