





Dear Ms. Ganacias Borja:

Pursuant to our conversation of April 4, 2000, please submit the information outlined below to our office within three days from the date of this letter. In compliance with required application procedure, please submit amended forms 601 and 602 with applicable mandatory exhibits. Please include in your submission the following ownership information, pursuant to Public Notices DA 00-508 and DA. 99-1001, released on March 6, 2000, and May 25, 1999, respectively, in order to complete your application:

Exhibit A: Ownership Information -- Identify the name of every direct owner holding 10% or more interest in the applicant along with their address, principal business, percentage of business held, and citizenship. It is also necessary to provide a list of 011 disclosable interests and entities along with their addresses, principal business, the amount of interest held, and citizenship of those companies.

Exhibit C: Designated Entity Eligibility -- Report the last three years of gross income for the applicant, the average of the applicant's gross income for the last three years, the gross income for the last three years for all affiliates, the average of the affiliate's gross income for the last three years, and the aggregate of the average gross incomes of the applicant and affiliates for the last three years.

Form 602: Please resubmit the form to correctly list L.P. Ganacias Enterprises on the form 602. Each of the direct owners must submit a form 602A disclosing their interest in applicant and any other interest held in a FCC regulated business.
