

REQUEST FOR CONFIDENTIAL TREATMENT OF TIN AND SSN INFORMATION

Re: CT Cube, Inc.
Ownership Disclosure Form (FCC Form 602)

Dear Sir/Madam:

Transmitted herewith, on behalf of CT Cube, Inc. ("CT Cube"), pursuant to 47 C.F.R. § 1.2 112 (a), is CT Cube's Federal Communications Commission ("FCC" or "Commission") Ownership Disclosure Report (FCC Form 602). CT Cube's FCC Form 602 is being filed in conjunction with CT Cube's application seeking consent to the pro forma transfer of control of its PCS licenses from Central Texas Telephone Investment, Inc. to Central Texas Telephone Management, LLC.

Although the Commission has stated that TIN and SSN information will not "be available to the public or Commission staff through ULS,"¹ CT Cube is nonetheless concerned about possible disclosure of this highly sensitive information. Although the information contained in this FCC Form 602 will be manually scanned into the FCC's Universal Licensing System (ULS) database and the TIN and SSN information will therefore not be made available to the public via




