





**WESTERN WIRELESS CORPORATION**

As reflected on the attached FCC Form 602, Western Wireless Corporation ("Western") is a Washington corporation with its principal business office located at 3650 13 1 st Avenue, S.E., Suite 400, Bellevue, Washington 98006. Western, through its subsidiaries and affiliates, owns, controls or has an interest in the entities listed in Attachment I which are FCC-regulated businesses.

Western has two classes of voting securities issued and outstanding: Class A Common Stock and Class B Common Stock. Class A has one vote per share and is publicly- traded: Class B has ten votes per share and is not publicly traded. The two classes are otherwise identical.

The following persons hold a 10 percent or greater ownership interest in either Class A or Class B Common Stock of Western:

Janus Capital Corporation ("Janus"), a Colorado corporation, holds 8,111,980 shares, or 11.3%, of the Class A Common Stock of Western. Janus' principal business address is 100 Fillmore Street, Denver, Colorado 80206.

T. Rowe Price ("T. Rowe"), a Maryland corporation, holds 7,196,800 shares, or 10.0%, of the Class A Common Stock of Western. T. Rowe's principal business address is Three Financial Center, 45 15 Painters Mill Road, Owings Mill, Maryland 2 1117.

PN Cellular, Inc. ("PN Cellular"), a Washington corporation, holds 1,686,069, or 24.0%, of the Class B Common Stock of Western. PN Cellular is owned 78.7% by John S. Stanton and Theresa Gillespie (see below), and its principal business address is P.O. Box 53508, Bellevue, Washington 98015-3508.

Stanton Communications Corporation ("SCC"), a Washington corporation, holds 1,274,519, or 18.2% of the Class B Common Stock of Western. SCC is owned 94.2% by John S. Stanton and Theresa Gillespie (see below), and its principal business address is P.O. Box 53508, Bellevue, Washing& 98015-3508.

John W. Stanton and Theresa E. Gillespie ("Stanton and Gillespie"), husband and wife, hold 6,050,693, or 86.3%, of the Class B Common Stock of Western.' Stanton and Gillespie are U.S.
