

Applicant Metronet Communications is owned 50% by Bryncomm, Inc., a Subchapter S corporation, and 50% by LenNet, L.P., a limited partnership. The reportable ownership of Bryncomm, Inc. is set forth the annexed Schedules A of Form 602. The sole general partner of LenNet, L.P. is LenNet Management, L.L.P., a limited liability partnership. The sole owner of LenNet Management, L.L.P., is Lenfest Group, L.L.C., a limited liability corporation. The members of Lenfest Group, L.L.C., are H. F. Lenfest, a U.S. citizen who owns 43.9%, and H. Chase Lenfest, a U.S. citizen who owns 56.1%. H. F. Lenfest and H. Chase Lenfest are father and son. The address for LenNet, L.P., LenNet Management, L.L.P. and Lenfest Group, L.L.C., H. F. Lenfest and H. Chase Lenfest is 1332 Enterprise Drive, West Chester, PA 19380.

Applicant has requested additional reportable information from the Lenfest interests and will amend and/or supplement this ownership report as soon as the additional information is received.
