





Applicant **Metronet Communications** is owned 50% by **Bryncomm, Inc.**, a Subchapter S corporation, and 50% by **LenNet, L.P.**, a limited partnership. The reportable ownership of **Bryncomm, Inc.** is set forth the annexed Schedules A of Form 602. The sole general partner of **LenNet, L.P.** is **Lenfest Group, L.L.C.**, a limited liability corporation. The only member of **Lenfest Group, L.L.C.** with a reportable interest is **H. F. Lenfest**, a U.S. citizen who owns 43.9%; the remaining ownership is divided equally among three children of **Mr. Lenfest**. In addition to being the largest owner of **Lenfest Group, L.L.C.**, **Mr. Lenfest** is the Chief Executive Officer and has the right contractually to control it.
