

Neoworld License Holdings, Inc. (“NLHI” or “Applicant”), a Delaware corporation, is a wholly-owned subsidiary of Neoworld, Inc., also a Delaware corporation. Both companies have their principal office located at 15 15 Broad Street, Bloomfield, New Jersey, 07003. Neoworld, Inc. is a wholly-owned subsidiary of Neoworld Holdings, LLC (“Neoworld”), a Delaware limited liability company.

***Ownership of Neoworld***

For the Commission’s convenience, attached hereto as Exhibit 2 is an organizational diagram for Applicant. There are four entities, all American companies, that hold ten percent (10%) or greater interest in Neoworld, the ultimate parent company of the Applicant. Their identity and associated ownership percentage are as follows:

The remaining ownership (32.6%) of Neoworld is held by a number of unitholders among them Columbia Capital; Hunt Financial Corporation; Northwood Ventures, LLC; and J.P. Morgan Capital Corp. None of these unitholders individually holds a ten percent (10%) or greater interest

in Neoworld. Each member of Neoworld Holdings, LLC, regardless of its percentage interest, is identified on the Form 602 with a separate Schedule A for each.

### ***Management of Neoworld***

Applicant's Board of Directors is comprised of the same individuals who are Members of Neoworld's Board of Managers. All such individuals are citizens of the United States.

Neoworld's Board of Managers include five representatives designated by Members holding or entitled to vote a majority of the Investor Equity held by all Members, *i.e.*, MDCP, Goldman Sachs, First Union and Sevin Rosen. The two representatives to the Board of Managers designated by MDCP are James N. Perry, Jr. and Douglas C. Grissom. Goldman Sachs' designated representative is David Pearson. First Union's representative is Watts Hamrick and Seven Rosen's representative is Jackie Kimzey.

Additionally, Brian D. McAuley and Andrew Daskalakis are the two representatives to the Board of Managers designated by the Members holding or entitled to vote a majority of the Management Equity held by all Members.

There remain two representative seats which have not been designated. These two will be designated by mutual agreement of a majority of the Investor Representatives and the Management Representatives. Neoworld intends to seek representatives with substantial telecommunications experience who are unaligned with any competitive service providers, including any domestic cellular, PCS, digital or analog SMR, or paging operator.

Brian M. McAuley, who was a co-founder of Fleet Call, Inc., now Nextel, and was its President and CEO from 1987 to 1993, is President and CEO of Neoworld. The Vice President of Indirect Distribution is Stanley A. DeCosmo, formerly a Senior Vice President for Motorola, Inc. with twenty-seven years of management experience in radio communications businesses, including sales and distribution. Neoworld's Vice President of Technology is Andrew Daskalakis, a qualified senior engineering consultant with over thirty years of experience in developing and implementing wireless communications, including senior level positions with Bell Laboratories, Motorola, Inc. and one of the initial cellular operators in New York City.

### ***FCC-Regulated Businesses of Disclosable Interest Holders***

As indicated on the Form 602, those entities that hold ten percent (10%) or greater interest in Neoworld are large institutional investors with a broad range of investments in the telecommunications industry. None of these investors will be involved in the day-to-day management decisions of Applicant. Applicant has requested from those entities and from the officers and directors of Neoworld all information necessary to complete the Form 602. The Form 602 and associated schedules reflect the responses received to date. Should Applicant receive data which substantially and significantly changes the information furnished in the Form, it will notify the Commission pursuant to FCC Rule Section 1.65.
