**REQUEST FOR CONFIDENTIAL TREATMENT OF TIN AND SSN INFORMATION**

**Re: New Mexico RSA 6-11 Partnership  
Ownership Disclosure Form (FCC Form 602)**

Dear Sir/Madam:

Transmitted herewith, on behalf of New Mexico RSA 6-II Partnership ("Partnership"), pursuant to 47 C.F.R. § 1.2112(a), is Partnership's Federal Communications Commission ("FCC" or "Commission") Ownership Disclosure Report (FCC Form 602). Partnership's FCC Form 602 is being filed in conjunction with Partnership's Renewal Application for Cellular Authorization for station **KNKQ336**.

Although the Commission has stated that TIN and SSN information will not "be available to the public or Commission staff through ULS,"<sup>1</sup> Partnership is nonetheless concerned about possible disclosure of this highly sensitive information. Although the information contained in this FCC Form 602 will be manually scanned into the FCC's Universal Licensing System (ULS)
