Northcoast presently holds 49 D, E and F block broadband PCS licenses. It does not hold any other FCC licenses, nor does it hold an ownership or controlling interest in any other entity regulated by the FCC. Neither Northcoast PCS or Cablevision PCS hold an ownership or controlling interest in any entity regulated by the FCC, other than Northcoast.

- B. **Antares II** does not directly hold any FCC licenses, nor does it have any pending applications for licenses. Further, **Antares II** does not hold an attributable interest in any entity that holds any FCC licenses or applications.
- C. CSC is a diversified media and communications company, which through its numerous subsidiaries and operating companies holds, FCC licenses and is otherwise generally subject to FCC regulation.
- D. AT&T is a diversified telecommunications company, which through its numerous subsidiaries, affiliates and operating companies holds numerous FCC licenses and applications.

Finally, other than John M.
