





## OWNERSHIP

Omnipoint Philadelphia License, LLC (“Philadelphia License”), submits the following information to describe in more detail the ownership structure of Philadelphia License as set forth in Item 10, Schedule A of FCC Form 602.

### Direct Ownership

Philadelphia License, a Delaware limited liability company, is a wholly owned subsidiary of Omnipoint Communications Enterprises, L.P (“OCE”), a Delaware limited partnership. The address of Philadelphia License is as follows:

### Indirect Ownership

OCE, a Delaware limited partnership, has two partners. The first partner is OPCS Philadelphia Holdings, LLC (“OPCS”), a Delaware limited liability company, which has a one percent (100% attributable) general partnership interest in, and is the sole general partner of, OCE. The second partner is Cook Inlet/V~~S~~ GSM II PCS, LLC (“CIVS II”), a Delaware limited liability company, which has a 99 percent limited partner interest in OCE. OPCS, in turn, is the wholly owned subsidiary of CIVS II. Thus, OCE is a wholly owned subsidiary of CIVS II.

CIVS II is the wholly owned subsidiary of Cook Inlet/V~~S~~ GSM II PCS Holdings, LLC (“CIVS II Holdings”), a Delaware limited liability company{

CIVS II Holdings, in turn, has two members. The first, Cook Inlet GSM, Inc. (“CIGSM”), a Delaware corporation, holds 50.1 percent of CIVS II Holdings and one hundred percent of the Class A membership interests in CIVS II Holdings.

CIGSM is, in turn, a wholly owned subsidiary of Cook Inlet Region, Inc. (“CIRI”). CIRI is an Alaska Native Regional Corporation organized pursuant to the Alaska Native Claims Settlement Act, 43 U.S.C. § 1601 *et seq.* (the “Act”). No CIRI shareholder holds a 10 percent or greater interest in CIRI or a 10 percent or greater indirect interest in Philadelphia License. |

The other member of CIVS II Holdings is VoiceStream PCS BTA I Corporation (“VS BTA I”), a Delaware corporation, which in turn is a wholly owned indirect subsidiary of VoiceStream Wireless Corporation (“VoiceStream”), a Delaware corporation. VS BTA I holds 49.9 percent of CIVS II Holdings and one hundred percent of the Class B nonvoting membership interests in CIVS II Holdings. |
