**REQUEST FOR CONFIDENTIAL TREATMENT OF TIN AND SSN INFORMATION**

**Re: Texas RSA 7B3, Inc. d/b/a Peoples Cellular  
Ownership Disclosure Form (FCC Form 602)**

Dear Sir/Madam:

Transmitted herewith, on behalf of Texas RSA 7B3, Inc. d/b/a Peoples Cellular (“Peoples Cellular”), pursuant to 47 C.F.R. § 1.2112(a), is Peoples Cellular’s Federal Communications Commission (“FCC” or “Commission”) Ownership Disclosure Report (FCC Form 602). Peoples Cellular’s FCC Form 602 is being filed in conjunction with Peoples Cellular’s Renewal Application for Cellular Authorization for station KNKN732.

Although the Commission has stated that TIN and SSN information will not “be available to the public or Commission staff through ULS,”<sup>1</sup> Peoples Cellular is nonetheless concerned about possible disclosure of this highly sensitive information. Although the information contained in this FCC Form 602 will be manually scanned into the FCC’s Universal Licensing System (ULS) database and the TIN and SSN information will therefore not be made available to the public via the ULS, Peoples Cellular requests that the FCC take whatever action is necessary

to ensure that the TINs and SSNs on the paper copy of the filing are not inadvertently made available to the public. Peoples Cellular therefore requests that the unredacted paper copy not be placed in the station's public file.


