





Hearne, Brendan G. Hearne, and **Megan E. Hearne** were held, respectively, by the Trust for the Benefit of Jennifer C. Hearne, Trust for the Benefit of Brendan G. Hearne & Trust for the Benefit of **Megan E. Hearne**. These 5% interests were, however, never held by the Trusts, but rather by the Trusts' beneficiaries directly, as reported in this exhibit.

Point Communications Company leases space on telecommunications towers in Oregon. Getting Air LLC holds a 15% non-voting interest in Biltmore Broadcasting, LLC, the licensee of KADY-TV in Oxnard, CA. Point Broadcasting Company is an FM broadcast station permittee and applicant in California. In addition, Point Broadcasting Company holds general partnership interests of 95 % and 88.5 1% , respectively in High Desert Broadcasting Company and Gold Coast Broadcasting Company:

John Q. Hearne, Jennifer C. Hearne, Brendan G. Hearne and **Megan E.** Hearne are all non-voting shareholders of Vista Communications, Inc. ("Vista"). Vista was the high bidder on two licenses in the 218-219 MHz Service (formerly the Interactive Video and Data Service) and has pending with the Commission a request for waiver of the grace period provisions of the FCC's Rules regarding license installment payments.
