REQUEST FOR CONFIDENTIAL TREATMENT OF TIN AND SSN INFORMATION

**Re: Central Texas Telephone Cooperative, Inc.
Ownership Disclosure Form (FCC Form 602)**

Dear Sir/Madam:

Transmitted herewith, on behalf of Central Texas Telephone Cooperative, Inc. ("CTTC"), pursuant to 47 C.F.R. § 1.2112 (a), is CTTC's Federal Communications Commission ("FCC" or "Commission") Ownership Disclosure Report (FCC Form 602). CTTC's FCC Form 602 is being filed in conjunction with CTTC's applications seeking consent to the conversion of CTTC's wholly owned subsidiary, Central Texas Telephone Investment, Inc., from a corporation to a limited partnership.

Although the Commission has stated that TIN and SSN information will not "be available to the public or Commission staff through ULS,"¹ CTTC is nonetheless concerned about possible disclosure of this highly sensitive information. Although the information contained in this FCC Form 602 will be manually scanned into the FCC's Universal Licensing System (ULS) database and the TIN and SSN information will therefore not be made available to the public via the ULS,




