

Exhibit A
Ownership Information

New England Sports Network, Inc. (“NESN”) submits the following information to describe in more detail the ownership structure of NESN.

Direct Ownership of NESN

NESN is a Massachusetts corporation. The sole shareholders of NESN are New England Associates, L.P. (“NEA”), a Massachusetts limited partnership, and Deeridge Farms Hockey Association (“DFHA”), a Delaware general partnership. Each of NEA and DFHA has a 50% economic interest in NESN; however, NEA has the right to appoint two-thirds of the directors of the Board of NESN, effectively giving NEA management control over NESN and a 100% attributable direct interest in NESN.

Indirect Ownership of NESN

The Jean R. Yawkey Trust, dated July 28, 1981, as amended (“Yawkey Trust”), a non-stock trust, has a 53.48% economic interest in and has managerial control over NEA, and a 53.48% attributable indirect interest in NESN. Yawkey Trust is the general partner and also a limited partner of NEA. The only other limited partners of NEA with an attributable interest in NESN of 10% or greater are Aramark Services, Inc. (“Aramark”), a Delaware corporation, with a 12.8% economic interest in NEA, and a 12.8% attributable indirect interest in NESN, and The Dexter Group (“Dexter”), a Maine general partnership, with a 15.12% economic interest in NEA, and a 15.12% attributable indirect interest in NESN. To NESN’s knowledge, no shareholder in Aramark and no partner in Dexter has a 10% or greater attributable interest in NESN.

Jeremy M. Jacobs has more than a 50% ownership interest in DFHA, and more than a 25% attributable indirect interest in NESN. To NESN’s knowledge, no other partner in DFHA has a 10% or greater attributable interest in NESN.

A graphic representation of the ownership structure of NESN is provided in Attachment 1 to this exhibit.

The following chart diagrams the ownership of New England Sports Network, Inc. described hereina:


