

AT&T COMCAST CORPORATION**

AT&T Comcast Corporation (“AT&T Comcast”) is a newly formed shell company organized under the laws of the Commonwealth of Pennsylvania. The authorized capital stock of AT&T Comcast consists of 100 share of Common Stock, par value \$0.01 per share, of which one share has been issued to Comcast Corporation (“Comcast”) and one share has been issued to AT&T Corp. (“AT&T”).

Comcast and AT&T have entered into an Agreement and Plan of Merger dated as of December 19, 2001 (the “Agreement”) under which Comcast and AT&T have agreed to combine Comcast and AT&T’s broadband business. Under the Agreement, AT&T Broadband Corp., a holding company for AT&T’s broadband division (“AT&T Broadband”), will be spun-off to AT&T’s shareholders. Upon completion of the spin-off, each of Comcast and AT&T Broadband will merge with and become a wholly-owned subsidiary of AT&T Comcast. After the completion of these transactions, AT&T Comcast will have a different ownership structure, which is described in the Application and Public Interest Statement filed by AT&T and Comcast in conjunction with the applications they are submitting seeking the Commission’s consent to transfer control of the various FCC licenses and authorizations held by their respective subsidiaries to AT&T Comcast. Exhibits A-1 and A-2 set forth the related FCC-regulated businesses of Comcast and AT&T Broadband.

This Form 602 is being filed in conjunction with the above-referenced transfer of control applications, and the information provided in this form is consequently based on the anticipated post-transfer ownership structure that will exist after FCC approval has been obtained and the transaction has been completed.

Comcast Corporation (“Comcast”) is a publicly-traded Pennsylvania corporation. Through its operating subsidiaries, Comcast is principally engaged in the business of developing, managing and operating hybrid fiber-coaxial broadband cable communications networks.
