**REQUEST FOR CONFIDENTIAL TREATMENT OF TIN AND SSN INFORMATION**

Re: **Texas RSA 20 B2 Limited Partnership d/b/a La Ward Cellular Ownership Disclosure Form (FCC Form 602)**

Dear Sir/Madam:

Transmitted herewith, on behalf of Texas RSA 20 B2 Limited Partnership d/b/a La Ward Cellular ("La Ward"), pursuant to 47 C.F.R. § 1.2 112(a), is La Ward's Federal Communications Commission ("FCC" or "Commission") Ownership Disclosure Report (FCC Form 602). La Ward's FCC Form 602 is being filed in conjunction with La Ward's microwave renewal applications.

Although the Commission has stated that TIN and SSN information will not "be available to the public or Commission staff through ULS,"<sup>1</sup> La Ward is nonetheless concerned about possible disclosure of this highly sensitive information. Although the information contained in this FCC Form 602 will be manually scanned into the FCC's Universal Licensing System (ULS) database and the TIN and SSN information will therefore not be made available to the public via the ULS, La Ward requests that the FCC take whatever action is necessary to ensure that the
