Prudential Insurance Company of America Schedule A

Response to Question 7: The Prudential Insurance Company of America (“Prudential”) and its affiliates will hold, in the aggregate, approximately 43% of the equity interests on a fully diluted basis, giving effect to certain Management Options provided for in the Agreement, in Country Road Communications, LLC (“CRC LLC”). Prudential will hold its interest in CRC LLC through shares held in Prudential’s name, shares held by two of Prudential’s affiliates, Prudential Securities Incorporated and PIM Warehouse, Inc., and through shares held by two investment funds that are also affiliates of Prudential. All of the ownership interests of Prudential and its affiliates have been aggregated for purposes of responding to this form.

Response to Question 8: It has not been determined whether Prudential will hold a voting or a non-voting equity interest in CRC LLC.

Response to Question 10: Prudential will hold a direct interest in CRC LLC which will wholly own Evans Telephone Holdings, Inc. which wholly owns Evans Telephone Company.

Response to Question 1 la: Prudential is a wholly-owned insurance company subsidiary of Prudential Financial, Inc., a publicly traded company, with affiliates engaged in a variety of services including primarily insurance, brokerage, investment services, banking and real estate. Across these businesses, Prudential and its affiliates collectively manage and/or administer assets of \$590 billion. Unsurprisingly, Prudential and its affiliates make and manage investments on a very broad, diversified basis. These investments include telecommunications and media companies plainly subject to regulation by the FCC, as well as companies with principal businesses outside the telecommunications and media industry but which nonetheless have FCC licenses or are otherwise in some tangential respect subject to regulation by the FCC. These companies may be either publicly traded or privately held.

Prudential has undertaken reasonable efforts to ensure compliance with FCC rules. First, it has established a policy for both itself and its affiliates of not acquiring interests that would be deemed under FCC rules to be “attributable” unless a special exception to this internal policy has been approved. Second, as an additional precaution, Prudential regularly tracks its investments in both public and private media companies known to be engaged in communications activities where Prudential’s interest (and those of its affiliates, in the aggregate) exceed a 3% level. Given the broad range of FCC attribution rules that address both ownership and positional interests, the limited availability of information about every line of business of every company in which Prudential or its affiliates might have some limited interest that might be subject to regulation by the FCC, and the daily changes to the relevant information, it is impossible to obtain absolute certainty in this area.

Using the regularly kept information described above, Prudential does not hold greater than a 10% position in any FCC-regulated businesses.

ABRY Partners IV, L.P. Schedule A

Response to Question 7: ABRY Partners IV, L.P. (“ABRY”) and a sister fund, ABRY Investment Partnership, L.P. (collectively, the “Investing ABRY Funds”), will invest a minimum of \$20 million in Country Road Holdings, LLC (“CRC LLC”), and as a result, obtain an equity ownership position of approximately 33.4%, on a fully diluted basis, giving effect to certain Management Options provided for in the Agreement. (ABRY’s investment will be substantially greater than that of ABRY Investment Partnership, L.P.; therefore, the Applicants identify ABRY as being the Transferee in their FCC Form 603 and other transfer of control applications filed with the FCC.) In addition, ABRY will acquire the right to appoint three of the seven members of CRC LLC’s Board of Directors. Each ABRY director will have two votes on all matters to be voted on by the Board of Directors, and each other director will have one vote, thereby giving ABRY a majority of the votes of CRC LLC’s Board of Directors.

The general partner of ABRY Partners IV, L.P. is ABRY Capital Partners, L.P. The general partner of ABRY Capital Partners, L.P. is ABRY Capital Partners, LLC. Neither of these companies has any other FCC-regulated businesses. The sole member of ABRY Capital Partners, LLC is Mr. Royce Yudkoff. Mr. Yudkoff’s FCC related information is provided in a separate Schedule A and Exhibit 6.

The Investing ABRY Funds have entered into a management agreement with ABRY Partners, a related company, which performs certain management functions on behalf of the Funds. ABRY Partners ultimately is controlled by Mr. Yudkoff.

The present management of Country Road will not change as a result of the proposed transaction. Harry Bennett will continue as Chairman and Chief Executive Officer of CRC LLC.

EXPLANATORY EXHIBIT

Section 1.948(c) of the Commission's Rules, 47 C.F.R. §1.948(c), governing transfers of control in the Wireless Radio Services, requires that a transferee subject to the ownership reporting requirements of Section 1.2112(a) file an updated FCC Form 602. The reporting requirements of Section 1.2112(a) of the Commission's Rules were modified by the Commission in *In re Amendment of Part I of the Commission's Rules -- Competitive Bidding Procedures*, Order on Reconsideration of the Third Report and Order, 13 FCC Rcd 15293 (Aug. 14, 2000) ("*Recon Order*"). Specifically, the Commission modified Section 1.2112(a) to streamline the information required to be filed by non-designated entity applicants, *inter alia*, by eliminating the requirement that non-designated entity applicants report their officers and directors. See *Recon Order* ¶¶10 and n.20; see also 47 C.F.R. §1.2112(a), as amended. The instructions to Form 602 have not been modified to distinguish between designated entity applicants and non-designated entity applicants in terms of the information required to be submitted. Consistent with the Commission's streamlining modifications to Section 1.2112(a), Evans Telephone Holdings, Inc. has not listed its officers and directors as disclosable interest holders in this Form 602.
