As reflected in the attached FCC Form 602, the managing general partner of **Acadiana Cellular General Partnership** (“Applicant”), with a 35% interest, is **BellSouth Mobility Inc** (“**BMI**”), which is a wholly-owned subsidiary of **BellSouth Cellular Corp.** (“**BSCC**”). **BSCC** is a wholly-owned subsidiary of **BellSouth Mobile Systems, Inc.** (“**BMW**”), which is a wholly-owned subsidiary of **BellSouth Enterprises, Inc.** (“**BSE**”). **BSE**, in turn, is a wholly-owned subsidiary of **BellSouth Corporation** (“**BSC**”).

**BMI**, **BSCC**, and **BSE** are Georgia corporations headquartered at 1100 Peachtree Street, N.E., Atlanta, Georgia 30309. **BMSI**, a Delaware corporation, also is headquartered at 1100 Peachtree Street, N.E., Atlanta, Georgia 30309. **BSC** is a Georgia corporation headquartered at 1155 Peachtree Street, N.E., Atlanta, Georgia 30309.

**BSC** is a publicly traded company. No person or entity is known to own more than five percent or more of its outstanding stock. **BSC** is a holding company providing telecommunications services, systems and products primarily through two wholly-owned subsidiaries, **BellSouth Telecommunications, Inc.** (“**BST**”) and **BSE**.

**BST**, a Georgia corporation, primarily provides tariffed public **landline** telephone service within localities in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.

**BSE** is the holding company for **BSC**’s investments in companies generally engaging in telecommunications activities other than public **landline** telephone services, including commercial and private mobile radio services, and advertising and publishing services. Such services include cellular, rural radio, point-to-point microwave, broadband personal communications, and private land mobile radio services. **BSC** subsidiaries also provide **wireline** and wireless cable services, data services, and long distance services in accordance with the Telecommunications Act of 1996.

The following lists FCC regulated businesses of Applicant and its disclosable interest holders — **BMI**, **BSCC**, **BMSI**, **BSE**, and **BSC** — beginning with **BSC**, Applicant’s ultimate corporate parent and the real party in interest. Entities which hold FCC licenses are indicated in bold italics; other entities are listed to make clear the relationship between Applicant and its disclosable interest holders. **TINs** are listed for these entities, as appropriate. Unless otherwise indicated, each entity is owned 100% by its parent company.

The remaining general partners in Applicant are (1) Louisiana Cellular, Inc. ("LCI") which holds a 32.5% interest in Applicant. LCI, in turn, is held equally between Alvin E. Kimball and I.V. Jeansonne, and; (2) Delcambre Cellular, Inc. ("DCI") which holds a 32.5% interest in Applicant. DCI, in turn, is held 100% by Lane J. LaBlanc.
