



FCC Ownership Disclosure Information for the Wireless Telecommunications Services

A. Disclosable Interest Holder Information

ACC New York License II LLC (“Filer”) is a subsidiary of American Cellular Wireless, LLC, (“ACW”) which owns 99.4% of Filer indirectly through its intervening subsidiaries Chill Cellular Corporation (“Chill”) and ACC of West Virginia Corporation (“ACC WV”). Filer is a wholly-owned subsidiary of Chill, which is 70.9% owned directly by ACW. ACC WV, a wholly-owned subsidiary of ACW, directly owns 28.5% of Chill. ACW is a wholly-owned subsidiary of American Cellular Corporation, which is a wholly-owned subsidiary of ACC Acquisition, LLC (“ACC Acq.”). ACC Acq. is jointly owned by Dobson JV Company (“DJV”), which holds a 50% membership interest and AT&T Wireless Services JV Co. (“AJV”), which holds a 50% membership interest. DJV is a wholly-owned subsidiary of Dobson Communications Corporation (“DCC”). DCC is a publicly traded company that is owned in majority by Dobson CC Limited Partnership (“DCCLP”), which holds an 81.4% voting interest.¹ No other entity directly holds a 10% or more interest in DCC.

The following entities which hold an ownership interest in DCCLP also hold an indirect disclosable ownership interest in Filer: a trust for the benefit of Everett R. Dobson holds a 50.49% limited partnership interest; a trust for the benefit of Stephen Dobson holds a 38.61% limited partnership interest; and RLD, Inc. holds a 1% general partnership interest in DCCLP. Everett R. Dobson and Don Cooke are the co-trustees of the trust for the benefit of Everett R. Dobson, and Everett R. Dobson and Stephen Dobson are the co-trustees for the trust for the benefit of Stephen Dobson. Everett R. Dobson holds 100% of RLD, Inc. Everett R. Dobson also holds directly 0.09% of the outstanding Class A common stock shares in DCC. Everett R. Dobson and Stephen Dobson are U.S. citizens and are siblings.

AJV is a wholly-owned subsidiary of AT&T Wireless Services, Inc., which in turn is a wholly-owned subsidiary of AT&T Corp (“AT&T”). AT&T is a publicly traded company. Further information regarding the ownership structure for these entities can be found on FCC Forms 602 submitted December 4, 2000 for AT&T and January 8, 2001 for AB Cellular LA, LLC.

To the extent that individual social security numbers are requested, Filer respectfully submits that such information will be provided to the Commission at such time as it can be assured that such information will remain confidential.

In addition to the above interest holders, Filer holds a 10% or greater ownership interest holders in the following commercial wireless licensees which are ultimately controlled by ACC
