



Transmitted herewith on behalf of BCO, Inc. ("BCO") is its FCC Form 602 for the disclosure of its ownership. The form is being filed as a result of BCO's participation in the 929/931 MHz Paging Auction (No. 26).

The Commission should note that BCO participated in the auction under temporary TIN [REDACTED]. This happened because the IRS had not yet issued BCO a Taxpayer identification Number at the time its Form 175 was due. The IRS subsequently issued BCO the TIN [REDACTED]. Upon the advice of Commission staff, BCO's Form 602 identifies its permanent TIN. BCO was also advised, however, to submit its electronic Form 601 using its temporary TIN, and then reconcile the discrepancy via a subsequent letter.
