







**OWNERSHIP DISCLOSURE STATEMENT**  
**BROADSTREAM COMMUNICATIONS CORPORATION**

**BroadStream Communications Corporation** (“**BroadStream Corp.**”), a Delaware corporation and FCC licensee of 39 GHz microwave facilities, owns 100 percent of **BroadStream Corporation** (“**Broadstream**”), which is also a Delaware corporation and a FCC licensee of 39 GHz microwave facilities. **BroadStream** and **BroadStream Corp.** were formerly called **CommcoTec Corporation** and **Commco Communications Corporation**, respectively, and had their names changed. Both entities’ principal business address is 45 13 Pin Oak Court, Sioux Falls, South Dakota 57103.

**BroadStream Corp.**’s outstanding common stock consists of 5,000,000 shares of Class A common stock and 15,000,000 shares of Class B common stock. As set forth on the attached “Ownership Structure Chart,” 100 percent of **BroadStream Corp.**’s common stock is owned by **Commco Partners, L.L.C.** (“**Commco Partners**”), a Delaware limited liability company. **Commco Partners**, in turn, has two types of shareholder units: Class A Units, which are voting, and Class B Units, which are non-voting. The ownership structure of **Commco Partners** is as follows:

I. **B. Scott Reardon, III** (“**Mr. Reardon**”) holds 1,000 Class A Units (0.005 percent of the membership units) in **Commco Partners**. Because only Class A Units can vote, **Mr. Reardon** has sole voting control in **Commco Partners**. **Mr. Reardon** is a United States citizen with nineteen years of experience in the telecommunications industry. He is the founder of **BroadStream** and **BroadStream Corp.** and is one of **BroadStream Corp.**’s directors. **Mr. Reardon**’s address is 908 East 35<sup>th</sup> Street, Sioux Falls, South Dakota 57105. As described below, **Mr. Reardon** is also president of **Forest Communications, L.L.C.** (“**Forest**”), an investment company.

II. **Horizon Technologies, L.L.C.** (“**Horizon**”) is a Delaware limited liability company that holds 6,355,981 Class B Units (3 1.775 percent of the membership units) in **Commco Partners**. **Horizon**’s principal business is to hold ownership interests in telecommunications companies. **Horizon**’s Manager and Chief Executive Officer is **Laurie L. Arthur** (“**Ms. Arthur**”), who is a United States citizen. The five members of **Horizon** are as follows: (1) the four members of **Forest**, which individually hold a 23.75 percent interest in **Horizon** and (2) **Ely Avenue Trust**, which holds a 5 percent interest in **Horizon**.’ **Horizon** and **Ms. Arthur**’s principal business address is 45 13 Pin Oak Court, Sioux Falls, South Dakota 57103.

III. **Commco, L.L.C.** (“**Commco**”) is a Delaware limited liability company that holds a 68.220 percent equity interest (13,644,019 Class B Units) in **Commco Partners**. **Commco**’s principal business is holding ownership interests in telecommunications companies, and its address is 45 13 Pin Oak Court, Sioux Falls, South Dakota 57103.

Equity ownership in **Commco** consists of 22,000 issued and outstanding Class A Units, which

are entitled to vote, and 1,078,000 issued and outstanding Class B Units, which are non-voting. The following is a description of Commco's Class A and B Unit holders:

- A). Dr. Rosemarie A. **Reardon** ("Dr. Reardon") holds 22,000 Class A Units in Commco. She is Chairman of the Board, a United States citizen, and a licensed psychologist. Her address is 908 East 35<sup>th</sup> Street, Sioux Falls, **South Dakota** 57105.
- B). New Dakota Investment Trust ("**NDIT**") is an investment trust that holds 110,000 Class B Units in Commco. Its address is 45 13 Pin Oak Court, Sioux Falls, South Dakota 57103. Mr. **Reardon** and River Trust Company are co-trustees.<sup>2</sup> Mr. **Reardon** is the primary beneficiary of **NDIT**.<sup>3</sup>
- C). Forest is a Delaware limited liability company that holds 968,000 Class B Units in Commco. Forest's principal business is holding ownership interests in telecommunications companies. Its principal business address is 45 13 Pin Oak Court, Sioux Falls, South Dakota 57103. Mr. **Reardon** is President of Forest. Forest has four members, which are trusts created by Dr. **Reardon** for the benefit of her children. The trustee of each trust is River Trust Company. The four members of Forest are as follows:

BSR Trust:  
("BSR") A trust created for the benefit of B. Scott **Reardon** IV, a child of Mr. and Dr. **Reardon**. BSR holds a 25 percent interest in Forest. Its business address is 45 13 Pin Oak Court, Sioux Falls, South Dakota 57103.

JDR Trust:  
("JDR") A trust created for the benefit of John Duggan **Reardon**, a minor child of Mr. and Dr. **Reardon**. JDR holds a 25 percent interest in Forest. Its business address is 45 13 Pin Oak Court, Sioux Falls, South Dakota 57103.

CAR Trust:  
("CAR") A trust created for the benefit of Courtney Anne **Reardon**, a minor child of Mr. and Dr. **Reardon**. CAR holds a 25 percent interest in Forest. Its business address is 4513 Pin Oak Court, Sioux Falls, South Dakota 57103.

MAFCR Trust:  
("MAFCR") A trust created for the benefit of Mia Alexandra **Reardon**, a minor child of Mr. and Dr. **Reardon**. MAFCR holds a 25



percent interest in Forest. Its business address is 45 13 Pin Oak Court, Sioux Falls, South Dakota 57103.

**IV. Other Interests.** Based on the criteria set forth in Section 1.2112(a)(3) of the Commission's Rules, David Knudson, Secretary of Commco and a United States citizen, holds a 12.4 percent shareholder interest in Satellite Cable Services, Inc. ("SCS"). SCS is the operator of 55 cable television systems in South Dakota serving 14,710 basic subscribers. **SCS's** business address is PO Box 106, 1027 Main Avenue South, Brookings, South Dakota 57006. Mr. Knudson is also Secretary of **BroadStream** and BroadStream Corp. and an attorney. His address is 513 S. Main Avenue, Sioux Falls, South Dakota 57104.

No other officer, director, attributable stockholder or key manager of **BroadStream** or **BroadStream** Corp. has an interest of 10 percent or greater in any FCC-regulated business.
