



America **Móvil**, S.A. de C.V. ("**América Móvil**") indirectly owns 50% of San Juan Cellular Telephone Company. SBC Communications Inc. indirectly owns approximately 7.7% of **América Móvil**. Carso Global Telecom, S.A. de C.V. owns approximately 28% of America **Móvil**.
