



Transmitted herewith, on behalf of CGKC&H No. 2 Rural Cellular Limited Partnership ("CGKC&H"), pursuant to 47 C.F.R. § 1.2 112(a), is CGKC&H's Federal Communications Commission ("FCC" or "Commission") Ownership Disclosure Report (FCC Form 602). CGKC&H's FCC Form 602 is being tiled in conjunction with CGKC&H's microwave renewal applications.

Although the Commission has stated that TIN and SSN information will not "be available to the public or Commission staff through ULS,"<sup>1</sup> CGKC&H is nonetheless concerned about possible disclosure of this highly sensitive information. Although the information contained in this FCC Form 602 will be manually scanned into the FCC's Universal Licensing System (ULS) database and the TIN and SSN information will therefore not be made available to the public via the ULS, CGKC&H requests that the FCC take whatever action is necessary to ensure that the


