

OWNERSHIP

Cook **Inlet/VS** GSM III PCS, LLC (“CIVS III”), submits the following information to describe in more detail the ownership structure of CIVS III as set forth in Item 10, Schedule A. of FCC Form 602.

Direct Ownership

CIVS III, a Delaware limited liability company, is a wholly owned subsidiary of **Cook Inlet/VS GSM III PCS Holdings, LLC (“CIVS III Holdings”)**, a Delaware limited liability company. The address of CIVS III is as follows:

Indirect Ownership


CIVS III Holdings has two members. The first, **Cook Inlet GSM, Inc. (“CIGSM”)**, a Delaware corporation, holds 50.1 percent of CIVS III Holdings and one hundred percent of the Class A membership interests in CIVS III Holdings.

CIGSM is, in turn, a wholly owned subsidiary of **Cook Inlet Region, Inc. (“CIRI”)**. CIRI is an Alaska Native Regional Corporation organized pursuant to the Alaska Native Claims Settlement Act, 43 U.S.C. § 1601 *et seq.* (the “Act”). No CIRI shareholder holds a 10 percent or greater interest in CIRI or a 10 percent or greater indirect interest in CIVS III.

The other member of CIVS III Holdings is **VoiceStream PCS BTA I Corporation (“VS BTA I”)**, a Delaware corporation, which in turn is a wholly owned indirect subsidiary of, **VoiceStream Wireless Corporation (“VoiceStream”)**, a Delaware corporation. VS BTA I holds 49.9 percent of CIVS III Holdings and one hundred percent of the Class B nonvoting membership interests in CIVS III Holdings.

OWNERSHIP

Cook Inlet/VS GSM III PCS, LLC (“CIVS III”), submits the following information to describe in more detail the ownership structure of CIVS III as set forth in Item 10, Schedule A of FCC Form 602.

Direct Ownership

CIVS III, a Delaware limited liability company, is a wholly owned subsidiary of Cook Inlet/VS GSM III PCS Holdings, LLC (“CIVS III Holdings”), a Delaware limited liability company. The address of CIVS III is as follows:

Indirect Ownership

CIVS III Holdings has two members. The first, Cook Inlet GSM, Inc. (“CIGSM”), a Delaware corporation, holds 50.1 percent of CIVS III Holdings and one **hundred percent** of the Class A membership interests in CIVS III Holdings.

CIGSM is, in turn, a wholly owned subsidiary of Cook Inlet Region, Inc (“CIRI”). CIRI is an Alaska Native Regional Corporation organized pursuant to the Alaska Native Claims Settlement Act, 43 U.S.C. § 1601 *et seq.* (the “Act”). No CIRI shareholder holds a 10 percent or greater interest in CIRI or a 10 percent or greater indirect interest in CIVS III.

The other member of CIVS III Holdings is **VoiceStream** PCS BTA I Corporation (“VS BTA I”), a Delaware corporation, which in turn is a wholly owned indirect subsidiary of **VoiceStream** Wireless Corporation (“**VoiceStream**”), a Delaware corporation. VS BTA I holds 49.9 percent of CIVS III Holdings and one hundred percent of the Class B nonvoting membership interests in CIVS III Holdings.
