

Transmitted herewith, on behalf of Crown Castle International Corp. de Puerto Rico, ("CCICP"), pursuant to 47 C.F.R. § 1.2112(a), is Federal Communications Commission ("FCC" or "Commission") Form 602. CCICP's FCC Form 602 is being filed in conjunction with CCICP's notification of pro forma transfer of control of CCICP for the above-referenced stations.

Although the Commission has stated that TIN and SSN information will not "be available to the public or Commission staff through ULS,"¹ CCICP is nonetheless concerned about possible disclosure of this highly sensitive information, Although the information contained in



this FCC Form 602 will be manually scanned into the FCC's Universal Licensing System (ULS) database and the TIN and SSN information will therefore not be made available to the public via the ULS, CCICP requests that the FCC take whatever action is necessary to ensure that the TINs and SSNs on the paper copy of the filing are not inadvertently made available to the public. CCICP therefore requests that the unredacted paper copy not be placed in the station's public file.


