



I. METHODOLOGY USED TO CALCULATE AND REPORT OWNERSHIP INTERESTS

The indirect ownership interests reported in parentheses in response to Item 7 of the Schedule A for each of applicant's disclosable interest holders were calculated using the multiplier approach set forth in Section 1.2 112(a)(5) of the Commission's rules.¹ Although not required by the Commission's rules. *compare 47 C.F.R. § 1.2112(a)(6) with 1.2 112(a)(5)*, the indirect ownership interests reported in parentheses for FCC-regulated businesses in response to Item 4(d) of the Main Form or Item 1 l(d) of the Schedule A (where applicable) were also calculated using the multiplier out of an abundance of caution. Interests not reported in parentheses, including direct ownership interests for which the multiplier is inapplicable, represent actual equity holdings.

Specifically, indirect interests in the applicant were determined by successive multiplication of the ownership percentage for each link in the vertical ownership chain, except that if the ownership percentage for an interest in any link in the chain exceeds 50 percent or represents actual control, then it was treated and reported as if it were a 100 percent interest. *Id.* Although the term "actual control" is typically synonymous with *de facto* control, *see, e.g., FCBA Petition for Forbearance*, 13 F.C.C.R. 6295, ¶ 7 (1998) ("*De facto* control is defined as actual control of the licensee . . ."), applicant has treated the term as encompassing all forms of control in an abundance of caution.

Description of Ownership

CCPR Services, Inc. is a corporation in which CCPR, Inc. holds a 99.9998 percent ownership-interest. CCPR, Inc. is a wholly owned subsidiary of Cellular Communications of Puerto Rico, Inc., which is a direct wholly owned subsidiary of SBC International Puerto Rico, Inc., which, in turn, is a wholly owned subsidiary of Beach Holding Corporation (“Beach”). Beach is owned indirectly by Cingular Wireless LLC (“Cingular”), which holds a 47 percent controlling interest; SBC Communications Inc. (“SBC”), which holds a 47 percent non-controlling interest; and VoiceStream Wireless Corporation (“VoiceStream”), which owns a 6 percent non-controlling interest. Cingular holds its 47 percent controlling interest in Beach through SBC Wireless – Puerto Rico. LLC, which is a wholly owned subsidiary of SBC Wireless LLC, which, in turn is a direct wholly owned subsidiary of Cingular. SBC holds its 47 percent non-controlling interest in Beach through SBC CCPR Holdings, LLC, which is a wholly owned subsidiary of SBC International, Inc., which, in turn, is a direct wholly owned subsidiary of SBC.

SBC, through various wholly owned subsidiaries, indirectly holds approximately 60 percent of Cingular’s LLC units. BellSouth Corporation (“BellSouth”), through various wholly owned subsidiaries, indirectly holds approximately 40 percent of Cingular’s LLC units. Cingular Wireless Corporation directly holds less than one percent of Cingular’s LLC units. SBC and BellSouth equally own and control Cingular Wireless Corporation, which – in addition to the *de minimis* ownership interest in Cingular – controls Cingular. Therefore, although the economic interests in Cingular are divided approximately 60/40 between SBC subsidiaries and BellSouth subsidiaries, control is equally shared. For a more detailed description of the wholly owned subsidiaries of SBC and BellSouth through which Cingular’s equity is held, please see the current FCC Form 602 on file for Cingular.’
