





The Prudential Insurance Company of America (“Prudential”) holds, in the aggregate, a 52.8% convertible nonvoting equity interest in Country Road Corn[REDACTED] Inc. (“Country Road”). At closing Prudential will become party to a stockholders agreement with other stockholders of Country Road (including the voting stockholders) that gives Prudential the right to designate two members of Country Road’s seven member board and to approve certain significant corporate acts, including the employment of senior executives of Country Road and the adoption of the annual business plan. Prudential holds its interest in Country Road through shares held in Prudential’s name, shares held by Prudential’s indirect wholly-owned subsidiary, Prudential Securities Incorporated (“Prudential Securities”), and through two investment funds that are also affiliates of Prudential. While the interest held by Prudential Securities is itself more than 10% of Country Road’s equity, all of the ownership interests of Prudential and these 3 affiliates have been aggregated for purposes of responding to this form.

Prudential is a mutual insurance company (i.e., owned by its policyholders) with affiliates engaged in a variety of services including primarily insurance, brokerage, investment services, banking and real estate. Across these businesses, Prudential and its affiliates collectively manage and/or administer assets worth nearly \$600 billion. Unsurprisingly, Prudential and its affiliates make and manage investments on a very broad, diversified basis. These investments include telecommunications and media companies plainly subject to regulation by the FCC, as well as companies with principal businesses outside the telecommunications and media industry but which nonetheless have FCC licenses or are

otherwise in some tangential respect subject to regulation by the FCC. These companies may be either publicly traded or privately held.

Prudential has undertaken reasonable efforts to ensure compliance with FCC rules. First, it has established a policy for both itself and its affiliates of not acquiring interests that would be deemed under FCC rules to be “attributable” unless a special exception to this internal policy has been approved. Second, as an additional precaution, Prudential regularly tracks its investments in both public and private media companies known to be engaged in communications activities where Prudential’s interest (and those of its affiliates, in the aggregate) exceed a 3% level. Given the broad range of FCC attribution rules that address both ownership and positional interests, the limited availability of information about every line of business of every company in which Prudential or its affiliates might have some limited interest that might be subject to regulation by the FCC, and the daily changes to the relevant information, it is impossible to obtain absolute certainty in this area.

Using the regularly kept information described above, Attachment A identifies the FCC regulated companies in which Prudential has a 10% or greater equity investment. As indicated, the information has been aggregated for Prudential and all of its affiliates (i.e., not only those affiliates holding an interest in Country Road). Note also that Attachment A tracks investments by the class or series of stock held. Thus, Attachment A reports the companies in which Prudential has investments that account for 10% or more of any class or series of stock of the company identified. To the extent that the companies identified on the chart have other classes or series of equity securities, the information set forth in Attachment A will overstate the percentage of Prudential’s equity investment.

SCP will own between .003% and .004% of the Fund. The Fund will hold, at minimum, a 33% equity interest in Country Road Communications, Inc. (“Country Road”), and, at maximum, a 39.6% interest in Country Road. As described in Country Road’s Schedule A, Country Road holds a 100% interest in Evans Telephone Company, the applicant. Accordingly, through these interests, SCP indirectly will hold at minimum a 0.099% equity interest in the applicant, and at maximum a 0.1584% interest in the applicant.
