

**FCC Ownership Disclosure Information for the
Wireless Telecommunications Services**

BellSouth Corporation ("BSC") is a publicly traded Georgia company, headquartered at 1155 Peachtree Street, N.E., Atlanta, Georgia 30309. No person or entity is known to own ten percent or more of its outstanding stock. BSC is a holding company providing telecommunications services, systems and products primarily through two wholly-owned subsidiaries, BellSouth Telecommunications, Inc. ("BST") and BellSouth Enterprises, Inc. ("BSE").

BST is a Georgia corporation headquartered at 675 W. Peachtree Street, N.E., Atlanta, GA 30375-0001. It primarily provides tariffed public landline telephone service within localities in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.

BSE is a Georgia corporation headquartered at 1155 Peachtree Street, N.E., Atlanta, Georgia 30309-3610. It is the holding company for BSC's investments in companies generally engaging in telecommunications activities other than public landline telephone services, including commercial and private mobile radio services, and advertising and publishing services. Such services include cellular, rural radio, point-to-point microwave, broadband personal communications, and private land mobile radio services.

BSC subsidiaries also provide wireline and wireless cable services, data services, and long distance services in accordance with the Telecommunications Act of 1996.

Attached is a list of BSC's FCC regulated businesses along with the BSC intermediate holding companies. TINs and FCC Registration Numbers ("FRNs") are listed for these entities, as appropriate. Additional information will be provided upon request.
