



First Digital holds Commission licenses in the 800 MHz Specialized Mobile Radio, Business Radio and Common Carrier Point-to-Point Microwave services. First Digital’s business address is 13444 L Street, Omaha, NE 68137.

First Digital holds no interest in other FCC-regulated businesses.

II. Disclosable Interest Holder Information

First Digital is wholly owned by First Wireless, Inc. (“FWI”), a Nebraska corporation. FWI is the sole and managing member of First Digital. FWI’s business address is 13444 L Street, Omaha, NE 68137. No individual or entity holds 10 percent or more of FWI.

FWI holds no interest in other FCC-regulated businesses.
