On 11/05/2019 the FCC consented to an assignment of authorization/transfer of control application involving the party indicated above. If you have not already done so, you have 180 days from the date of public notice of that consent, 04/22/2020, to act on the file number indicated below by 1) filing a notification of consummation; 2) filing an extension of time to consummate; or 3) filing a withdrawal request if the assignment of authorization/transfer of control will not be consummated.

- 1) To file a notification of consummation, use FCC Form 603 Main Form and Schedule D, Schedule for Notification of Consummation of Assignment of Authorization or Transfer of Control. Note: You must provide the actual date of consummation. This notification must be filed by the assignee/transferee.
- 2) To request an extension of time to consummate, use FCC Form 603 Main Form and Schedule E, Schedule for Request for Extension of Time for Consummation of Assignment of Authorization or Transfer of Control. Note: You must provide a new consummation expiration date and an exhibit providing justification for the extension request. This request must be filed by the assignor/transferor.
- 3) To file a withdrawal request, use FCC Form 603 Main Form. Note: You must indicate the application purpose is a withdrawal. This withdrawal must be filed by the assignor/transferor.

Assignment of authorizations/transfers of control are governed by 47 C.F.R. §1.948. The provisions pertaining to notification of consummation and extension of time to consummate are contained in § 1.948(d) and are printed below for your reference.

(d) Notification of consummation. In all Wireless Radio Services, licensees are required to notify the Commission of consummation of an approved transfer or assignment using FCC Form 603. The assignee or transferee is responsible for providing this notification, including the date the transaction was consummated. For transfers and assignments that require prior Commission approval, the transaction must be consummated and notification provided to the Commission within 180 days of public notice of approval, and notification of consummation must occur no later than 30 days after actual consummation, unless a request for an extension of time to consummate is filed on FCC Form 603 prior to the expiration of this 180-day period. For transfers and assignments that do not require prior Commission approval, notification of consummation must be provided on FCC Form 603 no later than 30 days after consummation, along with any necessary updates of ownership information on FCC Form 602.

**Failure to consummate within 180 days of Public Notice and to notify the FCC within that 180-day period and also within 30 days of the actual consummation date, or failure to request an extension of time to consummate within the 180 days of the Public Notice, will cause the original consent to the transfer or assignment to be automatically rescinded. If the consent is rescinded, the parties must file a new assignment of authorization/transfer of control application before they may consummate the transaction.**

The assignee may file a notification request electronically by using the ULS License Manager at <http://wireless.fcc.gov/uls> and select Online Filing. The License At A Glance Page will appear upon login. To file a notification in ULS, click on the link "Notify the FCC," in the Work on This License menu on the License At A Glance page. Use this link when notifying the FCC that a transfer of control or an assignment of authorization has been consummated. When selecting this link, you will need to select the purpose of submission as Notification of Consummation. Each required notification must be filed in accordance with the appropriate rules. Since your License At A Glance Page may have multiple call signs listed, the directions above may not work and you should contact the FCC Support Center listed below if you have any questions.
