See 47 C.F.R. § 1.946(e)(4).

If you fail to meet your construction/coverage requirement by its deadline, and you have not filed a request for an extension of time (FCC Form 601 & Schedule L) on or before the construction/coverage deadline pursuant to § 1.946(e)(4), the license will terminate automatically, in whole or in part (where applicable), without specific Commission action on the construction/coverage deadline date. See 47 C.F.R. § 1.946(c).
