The license(s) listed on the reverse side of this letter is subject to either construction or coverage requirements that must be completed by a specific date (Deadline Dates are noted on the reverse side). This Request for Extension of Time must be filed before the construction or coverage requirement deadline date. Note however, that filing an extension request does not automatically extend the construction or coverage period, unless the request is based on an involuntary loss of site or other circumstance beyond the licensee's control as provided in the Commission's rules. *See* 47 C.F.R. §1.946(e).

If you do not file your Required Notification or Request for Extension of Time before the appropriate deadline, ULS will presume that your license(s) has not been constructed, or the coverage requirement(s) has not been met, and place the license(s) into the Commission's Auto-Term process. If you do not complete construction or meet your coverage requirement before the applicable deadline, your license might terminate automatically, without specific Commission action on the date the construction or coverage period expires. *See e.g.*, 47 C.F.R. §§1.946(c), 27.14.
