Waiver of Sections 20.9(a)(6), 22.621, 22.627, and 90.309 is granted June 16, 2017.

Authorization is subject to implementation of Section 6103 of the Public Safety Spectrum Act, Pub. L. No. 112-96, 126 Stat. 156 (enacted February 22, 2012), which provides that, not later than nine years after the date of enactment, the Commission shall reallocate T-Band spectrum currently used by public safety eligibles. It also provides that relocation of public safety entities from the T-Band Spectrum shall be completed not later than two years after completion of the system of competitive bidding. See the Public Safety Spectrum Act, Section 6103(b), (c).

Because this is a new license granted after passage of the Public Safety Spectrum Act, Pub. L. No. 112-96, 126 Stat. 156 (enacted February 22, 2012), the licensee shall have no expectation of receiving funds to cover the cost of relocating the facilities covered by this authorization from the 470-512 MHz band spectrum. See the Public Safety Spectrum Act, Section 6103(b).
