The license(s) listed on the reverse side of this letter is subject to either construction or coverage requirements that must be completed by a specific date (Deadline Dates are noted on the reverse side). Note however, that filing an extension request does not automatically extend the construction or coverage period, unless the request is based on an involuntary loss of site or other circumstance beyond the licensee's control as provided in the Commission's rules. *See* 47 C.F.R. §1.946(e).
