Authorization is subject to implementation of Section 6103 of the Public Safety Spectrum Act, Pub. L. No. 112-96, 126 Stat. 156 (enacted February 22, 2012), which provides that, not later than nine years after the date of enactment, the Commission shall reallocate T-Band spectrum "currently used by public safety eligibles." It also provides that "relocation of public safety entities from the T-Band Spectrum" shall be completed not later than two years after completion of the system of competitive bidding. See the Public Safety Spectrum Act; §§ 6103(b), (c).

Because the addition of Location 4 (40-43-08.8 N, 073-23-34.9 W) is granted after passage of the Public Safety Spectrum Act, the licensee shall have no expectation of receiving funds to cover the cost of relocating the Location 4 (40-43-08.8 N, 073-23-34.9 W) facilities covered by this authorization from the 470-512 MHz band spectrum.
