Re: PUERTO RICO STATE POLICE

The license(s) referenced on the reverse side authorizes operation of a system of one or more facilities or frequencies and is subject to certain construction/coverage requirements that must be completed by a specific date. To confirm your compliance with the construction/coverage requirements, you must file FCC Form 601 Main Form & Schedule K, with the Commission no later than 15 days from the applicable construction/coverage deadline. See 47 C.F.R. § 1.946(d). The referenced license(s) has a construction/coverage deadline between 04/04/2014 and 04/10/2014.

You may request an extension of time to extend the construction/coverage period by filing FCC Form 601 Main Form & Schedule L, with the Commission **before** the construction/coverage deadline. *See* 47 C.F.R. § 1.946(e). The filing of such an extension request, however, does not automatically extend the construction/coverage period unless the request is based on an involuntary loss of site or other circumstance beyond the licensee's control, in which case the period is automatically extended pending disposition of the request. *See* 47 C.F.R. § 1.946(e)(4).

If you fail to meet your construction/coverage requirement by its deadline, and you have not filed a request for an extension of time (FCC Form 601 & Schedule L) on or before the construction/coverage deadline pursuant to § 1.946(e)(4), the license will terminate automatically, in whole or in part (where applicable), without specific Commission action on the construction/coverage deadline date. *See* 47 C.F.R. § 1.946(c).

For information on electronic filing, visit http://wireless.fcc.gov/uls. Most wireless services are required to file electronically. There are, however, a few radio services where manual filing is permitted. Licensees in services permitting manual filing can obtain application forms from the FCC's web site at http://www.fcc.gov/formpage.html, by calling the FCC's Forms Distribution Center toll free at 800-418-FORM (800-418-3676), or from FCC's Fax Information System by dialing 202-418-0177 on your touch tone telephone. Although manual filing is permitted for some services, we strongly encourage the use of electronic filing.
