## Re: COMMUNITY SCHOOL DISTRICT 95

If you are not going to meet the construction deadline(s) or coverage requirement(s) for your license(s), you may request an extension of the construction or coverage period(s) by filing a Request for Extension of Time. This Request for Extension of Time must be filed <u>before</u> the construction or coverage requirement deadline date. Note however, that filing an extension request does not automatically extend the construction or coverage period, unless the request is based on an involuntary loss of site or other circumstance beyond the licensee's control as provided in the Commission's rules. See 47 C.F.R. §1.946(e).

If you do not file your Required Notification or Request for Extension of Time before the appropriate deadline, ULS will presume that your license(s) has not been constructed, or the coverage requirement(s) has not been met, and place the license(s) into the Commission's Auto-Term process.
