Antennas employed for mobile use over 6.1 meters may be deployed without specific prior approval of the Commission provided that the overall height of such antennas more than 6.10 meters (20 feet) above ground, including their supporting structures (whether natural formation or man-made), do not exceed any of the slope ratios set forth in Section 17.7(b).

Fixed BAS and Low Power Auxiliary Stations in the UHF TV band are licensed on a secondary basis to existing -and future-primary operations and cannot cause harmful interference to primary operations nor claim protection from harmful interference from primary operations. In accordance with the spectrum provisions of the Middle Class Tax Relief and Job Creation Act of 2012 ("the Spectrum Act"), broadcast TV channel assignments could be reorganized and some UHF TV spectrum (470-698 MHz) could be allocatedfor flexible use and assigned by competitive bidding. These future assignments to primary licensees could require all existing and future BAS and Low Power Auxiliary stations to stop existing secondary operations and/or to change frequencies or bands attheir own expense.

Pursuant to the Second Report and Order in the Commission's Wireless Microphone proceeding (FCC 14-62), this authorization is issued with the condition that operation on repurposed UHF spectrum must cease by the end of the post-auction transition period, which will be 39 months after the release of the Channel Reassignment Public Notice.
