This letter is an important notice regarding the legal status of your license(s). The license(s) listed on the reverse side of this letter is subject to either construction or coverage requirements that must be completed by a specific date (Deadline Dates are noted on the reverse side). Note that mobile units authorized in the Land Mobile Radio Services are also required to comply with these requirements.

<u>If you have met</u> the construction or coverage requirement(s) for your license(s), you must file a Required Notification of Construction. This Notification of Construction must be filed no later than 15 days after the applicable construction or coverage requirement deadline. *See* 47 C.F.R. §1.946(d).

<u>If you are not going to meet</u> the construction deadline(s) or coverage requirement(s) for your license(s), you may request an extension of the construction or coverage period(s) by filing a Request for Extension of Time. This Request for Extension of Time must be filed <u>before</u> the construction or coverage requirement deadline date. Note however, that filing an extension request does not automatically extend the construction or coverage period, unless the request is based on an involuntary loss of site or other circumstance beyond the licensee's control as provided in the Commission's rules. *See* 47 C.F.R. §1.946(e).

If you do not file your Required Notification or Request for Extension of Time before the appropriate deadline, ULS will presume that your license(s) has not been constructed, or the coverage requirement(s) has not been met, and place the license(s) into the Commission's Auto-Term process. For more information, visit http://wireless.fcc.gov/licensing/const-req. If you do not complete construction or meet your coverage requirement before the applicable deadline, the license terminates automatically, without specific Commission action on the date the construction or coverage period expires. *See* 47 C.F.R. §1.946(c).

To submit a Notification of Construction or Extension Request, file an FCC Form 601 application. Electronic filing is required. For information on how to file an application electronically, visit the website at http://wireless.fcc.gov/uls.
