The filing of such an extension request, however, does not automatically extend the construction/coverage period unless the request is based on an involuntary loss of site or other circumstance beyond the licensee's control, in which case the period is automatically extended pending disposition of the request. See 47 C.F.R. § 1.946(e)(4).

If you fail to meet your construction/coverage requirement by its deadline, and you have not filed a request for an extension of time (FCC Form 601 & Schedule L) on or before the construction/coverage deadline pursuant to § 1.946(e)(4), the license will terminate automatically, in whole or in part (where applicable), without specific Commission action on the construction/coverage deadline date. See 47 C.F.R. § 1.946(c).
