Because the addition of Location 4 (40-44-49.2 N, 073-56-37.8 W) is granted after passage of the Middle Class Tax Relief and Job Creation Act of 2012, Pub. L. No. 112-96, 126 Stat. 156 (enacted February 22, 2012), the licensee shall have no expectation of receiving funds to cover the cost of relocating the Location 4 facilities covered by this authorization from the 470-512 MHz band spectrum. See the Middle Class Tax Relief and Job Creation Act of 2012, Section 6103(b).

At Location 4, the licensee must use a Sinclair SC329-HF3LDF(D06-G06) antenna or equivalent antenna with 6 degrees downtilt.

Conditions:

Pursuant to §309(h) of the Communications Act of 1934, as amended, 47 U.S.C. §309(h), this license is subject to the following conditions: This license shall not vest in the licensee any right to operate the station nor any right in the use of the frequencies designated in the license beyond the term thereof nor in any other manner than authorized herein. Waiver of the T-Band Suspension, DA 12-643, is granted.

Authorization is subject to implementation of Section 6103 of the Middle Class Tax Relief and Job Creation Act of 2012, Pub. L. No. 112-96, 126 Stat. 156 (enacted February 22, 2012), which provides that, not later than nine years after the date of enactment, the Commission shall reallocate T-Band spectrum “currently used by public safety eligibles.” It also provides that “relocation of public safety entities from the T-Band Spectrum” shall be completed not later than two years after completion of the system of competitive bidding. See the Middle Class Tax Relief and Job Creation Act of 2012, Section 6103(b), (c).
